| 12 | I, Gretchen Eoff, declare as follows: |
| 13 | I am a Senior Vice President of Operations of JND Legal Administration LLC |
| 14 | ("JND"), a nationally recognized legal administration firm. I have over fourteen years of |
| 15 | experience specializing in the administration of class action cases. JND was established in 2016 |
| 16 | and has administered hundreds of class action cases since its inception. |
| 17 | 2. This Declaration is based on my personal knowledge and information provided to |
| 18 | me by Counsel and experienced JND employees and, if called upon to do so, I could and would |
| 19 | testify competently thereto. |
| 20 | UPDATE ON SETTLEMENT ADMINISTRATION AND NOTICE PLAN |
| 21 22 | 3. Pursuant to the Court's Order dated On December 16, 2020 (ECF No. 1216, |
| 23 | "Preliminary Approval Order"), JND was retained as Claims Administrator to supervise and |
| 24 | administer the Class Notice Plan, as well as the processing of claims, in connection with the |
| 25 | Settlement ¹ in the above-captioned action. |
| 262728 | ¹ All capitalized terms not otherwise defined herein have the meanings set forth in the Stipulation and Agreement of Settlement, dated as of September 30, 2020 (ECF No. 1114, Ex. 1, the "Stipulation"). |

- 4. As noted in the Declaration of Gretchen Eoff Regarding Settlement Administration Status, dated March 10, 2022 (ECF No. 1724, "First Eoff Declaration"), JND has received a total of 81,179 timely claims (77,693 online and 3,486 by mail) and 62 untimely claims, as of March 3, 2022. JND completed processing of the significant volume of proof of purchase documentation claimants filed with their Claim Form(s).
- 5. JND has worked extensively with claimants filing a large volume of Keurig K-Cup Portion Pack purchases ("bulk filers"). Because of the difficulty of locating invoices for purchases for the entire Class Period, particularly for bulk filers, some claimants asked to be compensated at the documented claims rate for claims attested by the claimant's own records without external support. After presentation to Special Master Farnan by Settlement Class Counsel, claimants were given an opportunity to produce a verified transactional history together with a declaration from a person with responsibility for keeping and reviewing purchase records. Pursuant to this procedure, 73 claimants produced additional support for their timely-filed claims, and 60 produced no support, or support that was not sufficient to meet the standards identified to them after review of JND.

UPDATE ON TOLL-FREE TELEPHONE NUMBER AND EMAIL

- 6. JND maintains a toll-free telephone number for the Settlement (1-800-207-7160) for Class Members to call and obtain information about the Settlement in addition to a Settlement email address where they can contact JND with questions. JND continues to maintain the toll-free telephone number and email address and will continue to promptly address emailed questions from Class Members. First Eoff Declaration, ¶ 10.
- 7. As of February 9, 2023, JND has received 2,459 calls to the toll-free telephone number and 4,268 emails to the Settlement email address.

<u>UPDATE ON SETTLEMENT WEBSITE</u>

8. The First Eoff Declaration also noted that JND established a Settlement website for this case (www.KeurigIndirectPurchaserSettlement.com). JND continues to maintain the website. The Settlement website contains a current status, the case deadlines, and important documents.

9. As of February 9, 2023, the Settlement website has received 759,926 pageviews from 501,127 unique users.

STATUS OF CLAIMS PROCESSING

- 10. As of December 8, 2022, JND received 81,372 Proofs of Claim (hereafter referred to as "claims") in connection with this Settlement.² JND has carefully reviewed, analyzed, and processed all of these claims, and has responded to all claimant inquiries regarding the action, the Settlement and the procedures for filing claims. JND has also been in close contact with Lead Counsel to review the claim administration process. JND's weekly statistics report is attached hereto as **Exhibit A**.
 - 11. Additional detail regarding the status of claims is further detailed below:
 - a. <u>PROPERLY DOCUMENTED CLAIMS</u>: JND has identified 76,625³ properly documented valid claims. These valid claims represent a Claim Value of \$67,234,251.16⁴. These valid claims were calculated in the manner set forth in the Courtapproved Proposed Plan of Allocation ("Plan of Allocation"), included in the Notice. Attached as **Exhibit B-1** is a table detailing the 76,460 properly documented and timely submitted claims. Attached as **Exhibit B-2** is a table detailing the 165 properly documented late claims. It is JND's recommendation, and Plaintiffs concur, that the Court approve all 76,460 timely and properly documented claims as identified in **Exhibit B-1** and all 165 untimely and properly documented late claims as identified in **Exhibit B-1**

² Pursuant to the Preliminary Approval Order, Class Members who wanted to participate in the Settlement were required to submit a Proof of Claim postmarked no later than July 15, 2021. JND reviewed all Proofs of Claim it received, timely and untimely, and finalized its determination of which claims are authorized and which are ineligible.

³ This number includes 76,460 timely filed valid claims and 165 late but otherwise valid claims.

⁴ "Claim Value" reflects the total amount of K-Cup purchases, adjusted based on the Plan of Allocation. *See* ECF No. 1323 at 181-182 (Plan of Allocation and Claim Form). This amount includes timely filed, valid claims of \$67,122,035.43 and Claim Value for late (but otherwise valid) claims of \$112,215.73.

DEFICIENT AND INELIGIBLE CLAIMS: Many of the claims submitted b. were incomplete, not signed, not properly documented, or were otherwise deficient. If a claim was determined to be wholly deficient (for example, if the claim was missing documentation for the entire claim, or if the claimant did not sign the claim, or if the claimant did not provide enough information to calculate the Claim Value, or if the claim was determined to have no value when calculated under the Court-approved Plan of Allocation), JND sent the Claimant an Incomplete Claim Notice (Entire Claim). A sample Incomplete Claim Notice (Entire Claim) is attached hereto as **Exhibit C**. If a claim was determined to be partially deficient (for example, if the claimant was missing documentation for some transactions, or did not supply some transactional information), JND sent the claimant an Incomplete Claim Notice (Partial Claim). A sample Incomplete Claim Notice (Partial Claim) is attached hereto as **Exhibit D**. JND mailed (or e-mailed in the case of Electronic Claims) approximately 1,349 Incomplete Claim Notices (Entire Claim) and approximately 167 Incomplete Claim Notices (Partial Claim) in connection with claims filed throughout the Settlement administration. These Notices are referred to collectively as "Incomplete Claim Notices."

JND ultimately rejected 4,747 claims for the following reasons:

See **Exhibit E** for a table detailing the deficient and ineligible claims. It is JND's recommendation that all 4,747 deficient and ineligible claims as identified in **Exhibit E** be rejected.

c. <u>BULK FILER CLAIMS</u>: JND sent 133 additional notices to bulk filers. Of those 133 bulk filers, 28 did not respond. The remaining 105 bulk filer claim responses are summarized below with JND's recommendation for handling Settlement payment distribution:

- 12. In anticipation of completing this Settlement administration, JND respectfully requests that the Court reject as untimely any claims received after January 11, 2023, and any responses to deficiency and/or rejection notices received after January 2, 2022.
- 13. Should the Court concur with JND's determination concerning claim acceptance and rejection, JND recommends the following distribution plan:
 - (a) Per the Plan of Allocation, each Authorized Claimant shall be paid the percentage of the Net Settlement Fund that each Authorized Claimant's Claim Value bears to the total Claim Value of all 76,460 properly documented and timely submitted claims and 165 untimely and properly documented late claims, if the late claims are deemed valid by the Court. Per the terms of the Settlement, no distribution will be made on a claim where the potential distribution amount is less than \$10.00.

- (b) In order to encourage Authorized Claimants to deposit their distribution checks promptly, and to avoid or reduce future expenses relating to unpaid distribution checks, all checks should bear the notation, "DEPOSIT PROMPTLY, VOID AND SUBJECT TO RE-DISTRIBUTION 180 DAYS AFTER ISSUE DATE." Similarly, all other checks issued in connection with subsequent distributions shall bear the same notation.
- (c) If any funds remain in the Net Settlement Fund by reason of undeposited checks, or otherwise, after the JND has made reasonable and diligent efforts to have Authorized Claimants who are entitled to participate in the distribution of the Net Settlement Fund deposit their distribution checks, any balance remaining in the Net Settlement Fund six (6) months after the initial distribution of such funds shall be used: (i) first, to pay any amounts mistakenly omitted from the initial distribution to Authorized Claimants who would receive at least a \$10.00 payment; (ii) second, to pay any additional Notice and Settlement Administration Costs incurred in administering the Settlement; and (iii) finally, to make a second distribution to Authorized Claimants who cashed their checks from the initial distribution and who would receive at least \$10.00 from such second distribution, after payment of the estimated costs or fees to be incurred in administering the Net Settlement Fund and in making this second distribution, if such second distribution is economically feasible. If six (6) months after such second distribution, if undertaken, or if such second distribution is not undertaken, any funds shall remain in the Net Settlement Fund after JND has made reasonable and diligent efforts to have Authorized Claimants who are entitled to participate in this Settlement cash their checks, then such balance shall be donated to the Consumer Reports, a national non-profit consumer advocacy organization for investor protection.
- (d) Authorized Claimants who do not deposit their distribution checks within the time allotted will irrevocably forfeit all recovery from the Settlement unless good cause is shown. The funds allocated to all such stale-dated checks will be available for re-

distribution to other Authorized Claimants in subsequent distributions, if such distributions are determined to be economically feasible.
